Geographic Reach	<ul style="list-style-type: none"> Demonstrate that the entire Aspen to Parachute region is being served
Depth and Duration	<ul style="list-style-type: none"> Demonstrate regular, consistent interactions with clients -or- Demonstrate that services are delivered with fidelity to whatever model is being used
Cultural Responsiveness	<ul style="list-style-type: none"> Demonstrate culturally responsive program design -or- Demonstrate culturally responsive interactions with clients
Metrics and Impact	<ul style="list-style-type: none"> Clearly define the metrics used to determine impact Articulate impact using metrics data
